**Studio J Dance Payment Policies**  
**Please read these policies carefully before signing**

- Registration fee (non-refundable) \$25.00 for one child \$35.00 per family (2 or more). These fees are NON-REFUNDABLE for any reason.
- All tuition is due on the 1<sup>st</sup> of each month of the dance year, regardless of what day of the week the first falls. This includes weekends and holidays when the studio is closed. Payments may always be mailed to Studio J Dance.
- After the 10<sup>th</sup> of the month, tuition payments are considered late and a \$10.00 late fee will be added to your account. If it is after the 15<sup>th</sup> of the month it will be \$15.00 late fee and \$5 for every week its late. All late charges will be carried over each month.
- The price of tuition is based on an average of four classes per month and is not altered for months with holidays, etc. in which less than four classes are held. The extra lessons received during any five week month are applied to the days the studio is closed for holidays.
- No refunds or deductions are given if a student misses a class for any reason. Makeup classes are available for missed lessons.
- If for any reason it becomes necessary to withdraw a child from a class, it must be in writing with a 2 week notice. If it is not in writing the person responsible for payment will be billed the regular tuition amount. Non attendance is not considered withdrawal from class.
- Accounts must have a \$0 balance for the student to participate in the recital.
- You must pay the recital fee in order to receive your costume. We do not sell just a costume it goes along with the recital.
- There will be a \$25.00 charge for all checks returned from your bank
- Yearly payment option: Parents may choose to pay full tuition for the year and receive a 10% discount. This payment must be made by September 1<sup>st</sup>. for the discount to apply. Payment is non-refundable for any reason.

I, undersigned, understand and agree to follow the policies outlined above. I also fully understand and agree that the organizers, owners, or instructors of Studio J Dance shall be free from any liability of claims arising by reason of any injury or illness at Studio J Dance. Permission is hereby granted to transport my child to a doctor or hospital in case of illness or injury, when unable to locate a parent. I understand that all students, as well as anyone entering Studio J Dance, are expected to follow all the studio rules and that the studio reserves the right to dismiss anyone whose conduct is unsatisfactory.
